

**Application Instructions:** Please review the Assignment of Points form prior to submitting your application to ensure you meet the necessary requirements (score) for becoming an IATP Fellow. This application is broken down into three sections: Qualifications, Professional Experience and Recognition of Scientific Leadership. Each section must be filled in completely. Please provide as much detail as possible in each section so that the Accreditation Committee can accurately assess your expertise in each category. If there is a section that is not applicable to you, please indicate in the box provided. Incomplete applications will be returned.

You must complete the online payment section (step 4 of the application process) in order for your application to be submitted. You may submit payment online via PayPal. If you would prefer to pay by check or wire transfer, please contact the IATP Executive Office ([iatpfellows@gmail.com](mailto:iatpfellows@gmail.com)).so that your payment information can be entered manually into the system. Your applications will not be sent out for review until your payment is received.

**Important:** If you log out of the system before completing the entire application, any information you have entered will not be saved and you will need to begin the process over again. We recommend you make a copy of the application and save it on your computer to avoid any problems.

Please upload a copy of your most recent CV with your application. Please note, your CV is being provided as supplemental information and should not be used in place of completing the application. Please do not put "See CV" in any of the section boxes. Doing so will render your application incomplete and it will be returned to you.

Upon receipt of your application, it will be sent to the Accreditation Committee Chair to review for completeness. Upon approval, it will be sent to the Accreditation Committee for review and scoring. You will receive a decision, in writing, on the outcome of your application within one month of the date submitted. Information on the Academy's appeal process can be found on the website.

**Research Training** – 6 points available in this section


List your research degrees ((state discipline, institution and number of years). For non-degree research, please list the mentor’s name and position; the institution, the number of years and the area of research.

### **Continuing Education**- 5 points available in this section

List continuing education activities with the number of hours or days for the last 5 years. Continuing education can include organizational, university, professional society-sponsored (STPs, ACVP, BSTP, ESTP, ECVP, JSTP, SOT, ACT, etc.) meetings, courses or other training (e.g. webinars) related to toxicologic pathology.



## SECTION B. PROFESSIONAL EXPERIENCE

**Unpublished Author Reports** – 8 points available in this section.

Enter the number of reports (research reports and other internal reports) related to toxicologic pathology that you have authored either as a sole author, primary author, or contributing author. Published papers are excluded from this section. 30 reports is the minimum number required

In the section below, give an overview of the unpublished reports and other documents that you have authored. Study reports or pathology sections of study reports should be categorized as acute toxicity, chronic toxicity, carcinogenicity, reproductive toxicity or special toxicity study reports. Other prepared documents should be categorized as appropriate (e.g. preparation of IND/NDA documents; prepared responses to regulatory concerns or “White Papers” that were prepared to summarize toxicity issues for internal use within a company). For experimental work, most notably academic experimental studies, preparation of progress reports and final reports to granting agencies or other funding sources should be categorized as to type of report. It is very important that your role and contribution for each category of report be identified (e.g. sole author, primary author, or contributing author). You should categorize the types of reports and your contribution, but should not list individual reports since this could breach institutional confidentiality.

**SECTION B. PROFESSIONAL EXPERIENCE**

**Reviews and Books Chapters** - 7 points available in this section

List major relevant reviews and book chapters, especially as first, second, or last author and your role in each contribution.

**SECTION C. RECONITION OF SCIENTIFIC JUDGEMENT**

**Editorial Responsibilities – 5 points available in this section**

List your editorial responsibilities (Editor, Associate or Section Editor or Editorial Board Member). Include the name of the journal and the number of years served in each position. If you have less than 5 points in this section (Editors receive 1 point per year; Associate or Section Editors receive .75 points per year; and Editorial Board members receive .5 points per year), also list the number of manuscripts you have reviewed, and the journals that you have reviewed for, over last 5 years.

**SECTION C. RECOGNITION OF SCIENTIFIC JUDGEMENT**

**Invited Papers, Presentations, Seminars, and Posters – 9 points available in this section.**

List invited papers, seminars, poster discussions (maximum of 10) and briefly describe content and forum for each item, as well as your contribution if multiple authors are listed.

**SECTION C. RECONITATION OF SCIENTIFIC JUDGEMENT**

**Scientific Leadership – 12 points available in this section**

List activities such as committee volunteer, officer, or presenter for societies; scientific panels for government agencies; and/or participation in working groups that impact regulatory issues.



**SECTION C. RECOGNITION OF SCIENTIFIC JUDGEMENT**

**Awards**- *5 points available in this section*

List awards and other recognitions relevant to toxicologic pathology, toxicology or pathology and the year attained. Include any Boards given by fellow recognition or peer review (e.g. Academy of Toxicological Sciences, etc.) and the year attained in this section.



**SECTION C. RECOGNITION OF SCIENTIFIC JUDGEMENT**

**Mentorship** – *5 points available in this section*

For Mentors - list and provide specifics of mentorship in pathology/toxicologic pathology of less experienced pathologists (formal and informal) and students (veterinary students, residents, PhD students).

For Mentee - indicate name, position when mentored, current position if any (title, employer) and your role and period mentored.

Mentoring is defined as a professional relationship in which an experienced person (the mentor) assists another (the mentee) in developing specific skills and knowledge that will enhance the less-experienced person’s professional growth in toxicologic pathology.

Include innovative fields of toxicologic pathology if applicable. Cite references (including internal reports), awards, and committee leadership as appropriate.

Examples:

- Description of a new type of drug-induced pathology, including potential mechanistic studies with appropriate references.
- Contribution to a special professional STP committees (like INHAND, Regulatory affairs, annual meetings, etc.).
- Use of expertise in toxicologic pathology to impact other scientific areas or society in general.
